TECHNICAL BID RE-EVALUATION

S. Asheli** has submitted a complaint/ request against the Technical Bid Evaluation report of PMGSY Phase-XI (Batch-I) dtd. 17/03/2018.

Accordingly the duly constituted Technical Bid Evaluation Committee of PMGSY Phase-XI (batch-I) has rechecked/ re-evaluated all the bids (documents) of **Package No. MN06279** after a complaint filed by Shri L.S. Asheli on 23/03/2018 and the details of finding are as follows:-

1. No Organization Chart has been prepared by M/s HVS Construction Materials Pvt. Ltd. despite minute no. 14 of the pre-Bid meeting hence the information/ document is incomplete.	<ul style="list-style-type: none"> ➤ Not mandatory to submit Orgn. Chart as per the new prescribed SBD of PMGSY Phase-XI (Batch-I). ➤ Minute no. 14 of the Pre-Bid Meeting stated that: "Organisation Chart should be properly prepared depending on the type of organization (Individual/ firm)". But it is not mentioned that the orgn. Chart should be mandatorily uploaded as a part of bidder's profile.
2. Bar chart of the Action Plan has not been signed hence to be treated as null and void.	Since All the documents uploaded by the bidder on the tendering site are digitally signed by bidder's DSC (Digital Signature Certificate), all the online submitted documents are considered as signed by the bidder except all affidavits and for those documents for which a specific format is given in the SBD.
3. Credit Facility obtained from Punjab & Sind Bank, Imphal Branch but no Banker Details of the bank has been provided for reference of the Employer.	The bidder has submitted a Credit Facility Certificate issued by Punjab & Sind Bank on the bank's letter head having all necessary details like Bank Address, Contact number and email of the Banker. So no point of missing banker details.
Committee's Decision after re-verification/ re-evaluation:	
The complaint filed by L.S. Asheli has been duly considered by the Tender Committee however his complaint/ request is found to be unacceptable based on the Committee's findings. Therefore, <u>the Committee's earlier decision on acceptance of the bid of M/s HVS Construction Materials Pvt. Ltd. shall remain as it is based on the above ground.</u>
